## Handout 2 : The Dirac Equation

## Non-Relativistic QM (Revision)

- For particle physics need a relativistic formulation of quantum mechanics. But first take a few moments to review the non-relativistic formulation QM
- Take as the starting point non-relativistic energy:

$$
E=T+V=\frac{\vec{p}^{2}}{2 m}+V
$$

- In QM we identify the energy and momentum operators:

$$
\vec{p} \rightarrow-i \vec{\nabla}, \quad E \rightarrow i \frac{\partial}{\partial t}
$$

which gives the time dependent Schrödinger equation (take $\mathrm{V}=0$ for simplicity)

$$
\begin{equation*}
-\frac{1}{2 m} \vec{\nabla}^{2} \psi=i \frac{\partial \psi}{\partial t} \tag{S1}
\end{equation*}
$$

with plane wave solutions: $\quad \psi=N e^{i(\vec{p} \cdot \vec{r}-E t)} \quad$ where $\quad\left\{\begin{array}{r}-i \nabla \psi=\vec{p} \psi \\ i \frac{\partial \psi}{\partial t}=E \psi\end{array}\right.$
SE is first order in the time derivatives and second order in spatial derivatives - and is manifestly not Lorentz invariant.

- In what follows we will use probability density/current extensively. For the non-relativistic case these are derived as follows
(S1)*

$$
\begin{equation*}
-\frac{1}{2 m} \vec{\nabla}^{2} \psi^{*}=-i \frac{\partial \psi^{*}}{\partial t} \tag{S2}
\end{equation*}
$$

$$
\begin{aligned}
\psi^{*} \times(\mathbf{S} 1)-\psi \times(\mathbf{S} 2):-\frac{1}{2 m}\left(\psi^{*} \nabla^{2} \psi-\psi \nabla^{2} \psi^{*}\right) & =i\left(\psi^{*} \frac{\partial \psi}{\partial t}+\psi \frac{\partial \psi^{*}}{\partial t}\right) \\
-\frac{1}{2 m} \vec{\nabla} \cdot\left(\psi^{*} \vec{\nabla} \psi-\psi \vec{\nabla} \psi^{*}\right) & =i \frac{\partial}{\partial t}\left(\psi^{*} \psi\right)
\end{aligned}
$$

-Which by comparison with the continuity equation

$$
\vec{\nabla} \cdot \vec{j}+\frac{\partial \rho}{\partial t}=0
$$

leads to the following expressions for probability density and current:

$$
\rho=\psi^{*} \psi=|\psi|^{2} \quad \vec{j}=\frac{1}{2 m i}\left(\psi^{*} \vec{\nabla} \psi-\psi \vec{\nabla} \psi^{*}\right)
$$

- For a plane wave $\psi=N e^{i(\vec{p} \cdot \vec{r}-E t)}$

$$
\rho=|N|^{2} \quad \text { and } \quad \vec{j}=|N|^{2} \frac{\vec{p}}{m}=|N|^{2} \vec{v}
$$

* The number of particles per unit volume is $|N|^{2}$

For $|N|^{2}$ particles per unit volume moving at velocity $\vec{v}$, have $|N|^{2}|\vec{v}|$ passing through a unit area per unit time (particle flux). Therefore $\vec{j}$ is a vector in the particle's direction with magnitude equal to the flux.

## The Klein-Gordon Equation

- Applying $\vec{p} \rightarrow-i \vec{\nabla}, \quad E \rightarrow i \partial / \partial t$ to the relativistic equation for energy:

$$
\begin{equation*}
E^{2}=|\vec{p}|^{2}+m^{2} \tag{KG1}
\end{equation*}
$$

gives the Klein-Gordon equation:

$$
\begin{equation*}
\frac{\partial^{2} \psi}{\partial t^{2}}=\vec{\nabla}^{2} \psi-m^{2} \psi \tag{KG2}
\end{equation*}
$$

- Using $\partial_{\mu} \equiv \frac{\partial}{\partial x^{\mu}}=\left(\frac{\partial}{\partial t}, \frac{\partial}{\partial x}, \frac{\partial}{\partial y}, \frac{\partial}{\partial z}\right) \Rightarrow \partial^{\mu} \partial_{\mu} \equiv \frac{\partial^{2}}{\partial t^{2}}-\frac{\partial^{2}}{\partial x^{2}}-\frac{\partial^{2}}{\partial y^{2}}-\frac{\partial^{2}}{\partial z^{2}}$

KG can be expressed compactly as

$$
\begin{equation*}
\left(\partial^{\mu} \partial_{\mu}+m^{2}\right) \psi=0 \tag{KG3}
\end{equation*}
$$

-For plane wave solutions, $\quad \psi=N e^{i(\vec{p} \cdot \vec{r}-E t)}$, the KG equation gives:

$$
\begin{gathered}
-E^{2} \psi=-|\vec{p}|^{2} \psi-m^{2} \psi \\
\Rightarrow E= \pm \sqrt{|\vec{p}|^{2}+m^{2}}
\end{gathered}
$$

Not surprisingly, the KG equation has negative energy solutions - this is just what we started with in eq. KG1

- Historically the -ve energy solutions were viewed as problematic. But for the KG there is also a problem with the probability density...
-Proceeding as before to calculate the probability and current densities:

$$
\begin{aligned}
(\mathrm{KG} 2)^{*} & \frac{\partial^{2} \psi^{*}}{\partial t^{2}}
\end{aligned} \vec{\nabla}^{2} \psi^{*}-m^{2} \psi^{*} \mathrm{\psi}^{*} \times(\mathbf{K G 2})-\psi \times(\mathbf{K G 4}): \begin{aligned}
\psi^{*} \frac{\partial^{2} \psi}{\partial t^{2}}-\psi \frac{\partial^{2} \psi^{*}}{\partial t^{2}} & =\psi^{*}\left(\nabla^{2} \psi-m^{2} \psi\right)-\psi\left(\nabla^{2} \psi^{*}-m^{2} \psi^{*}\right) \\
\frac{\partial}{\partial t}\left(\psi^{*} \frac{\partial \psi}{\partial t}-\psi \frac{\partial \psi^{*}}{\partial t}\right) & =\vec{\nabla} \cdot\left(\psi^{*} \vec{\nabla} \psi-\psi \vec{\nabla} \psi^{*}\right)
\end{aligned}
$$

-Which, again, by comparison with the continuity equation allows us to identify

$$
\rho=i\left(\psi^{*} \frac{\partial \psi}{\partial t}-\psi \frac{\partial \psi^{*}}{\partial t}\right) \quad \text { and } \quad \vec{j}=i\left(\psi^{*} \vec{\nabla} \psi-\psi \vec{\nabla} \psi^{*}\right)
$$

-For a plane wave $\quad \psi=N e^{i(\vec{p} \cdot \vec{r}-E t)}$

$$
\rho=2 E|N|^{2} \quad \text { and } \quad \vec{j}=|N|^{2} \vec{p}
$$

*Particle densities are proportional to $E$. We might have anticipated this from the previous discussion of Lorentz invariant phase space (i.e. density of $1 / V$ in the particles rest frame will appear as $E / V$ in a frame where the particle has energy $E$ due to length contraction).

## The Dirac Equation

* Historically, it was thought that there were two main problems with the Klein-Gordon equation:
- Negative energy solutions
- The negative particle densities associated with these solutions

$$
\rho=2 E|N|^{2}
$$

* We now know that in Quantum Field Theory these problems are overcome and the KG equation is used to describe spin-0 particles (inherently single particle description $\rightarrow$ multi-particle quantum excitations of a scalar field).


## Nevertheless:


*These problems motivated Dirac (1928) to search for a different formulation of relativistic quantum mechanics in which all particle densities are positive.

* The resulting wave equation had solutions which not only solved this problem but also fully describe the intrinsic spin and magnetic moment of the electron!


## The Dirac Equation :

-Schrödinger eqn:

$$
-\frac{1}{2 m} \vec{\nabla}^{2} \psi=i \frac{\partial \psi}{\partial t} \quad \begin{array}{ll}
1^{\text {st }} \text { order in } & \partial / \partial t \\
2^{\text {nd }} \text { order in }
\end{array} \quad \partial / \partial x, \partial / \partial y, \partial / \partial z
$$

- Klein-Gordon eqn: $\quad\left(\partial^{\mu} \partial_{\mu}+m^{2}\right) \psi=0 \quad 2^{\text {nd }}$ order throughout
- Dirac looked for an alternative which was $1^{\text {st }}$ order throughout:

$$
\begin{equation*}
\hat{H} \psi=(\vec{\alpha} \cdot \vec{p}+\beta m) \psi=i \frac{\partial \psi}{\partial t} \tag{D1}
\end{equation*}
$$

where $\hat{H}$ is the Hamiltonian operator and, as usual, $\vec{p}=-i \vec{\nabla}$
-Writing (D1) in full:

$$
\left(-i \alpha_{x} \frac{\partial}{\partial x}-i \alpha_{y} \frac{\partial}{\partial y}-i \alpha_{z} \frac{\partial}{\partial z}+\beta m\right) \psi=\left(i \frac{\partial}{\partial t}\right) \psi
$$

"squaring" this equation gives
$\left(-i \alpha_{x} \frac{\partial}{\partial x}-i \alpha_{y} \frac{\partial}{\partial y}-i \alpha_{z} \frac{\partial}{\partial z}+\beta m\right)\left(-i \alpha_{x} \frac{\partial}{\partial x}-i \alpha_{y} \frac{\partial}{\partial y}-i \alpha_{z} \frac{\partial}{\partial z}+\beta m\right) \psi=-\frac{\partial^{2} \psi}{\partial t^{2}}$

- Which can be expanded in gory details as...

$$
\begin{aligned}
-\frac{\partial^{2} \psi}{\partial t^{2}}= & -\alpha_{x}^{2} \frac{\partial^{2} \psi}{\partial x^{2}}-\alpha_{y}^{2} \frac{\partial^{2} \psi}{\partial y^{2}}-\alpha_{z}^{2} \frac{\partial^{2} \psi}{\partial z^{2}}+\beta^{2} m^{2} \psi \\
& -\left(\alpha_{x} \alpha_{y}+\alpha_{y} \alpha_{x}\right) \frac{\partial^{2} \psi}{\partial x \partial y}-\left(\alpha_{y} \alpha_{z}+\alpha_{z} \alpha_{y}\right) \frac{\partial^{2} \psi}{\partial y \partial z}-\left(\alpha_{z} \alpha_{x}+\alpha_{x} \alpha_{z}\right) \frac{\partial^{2} \psi}{\partial z \partial x} \\
& -\left(\alpha_{x} \beta+\beta \alpha_{x}\right) m \frac{\partial \psi}{\partial x}-\left(\alpha_{y} \beta+\beta \alpha_{y}\right) m \frac{\partial \psi}{\partial y}-\left(\alpha_{z} \beta+\beta \alpha_{z}\right) m \frac{\partial \psi}{\partial z}
\end{aligned}
$$

- For this to be a reasonable formulation of relativistic QM, a free particle must also obey $E^{2}=\vec{p}^{2}+m^{2}$, i.e. it must satisfy the Klein-Gordon equation:

$$
-\frac{\partial^{2} \psi}{\partial t^{2}}=-\frac{\partial^{2} \psi}{\partial x^{2}}-\frac{\partial^{2} \psi}{\partial y^{2}}-\frac{\partial^{2} \psi}{\partial z^{2}}+m^{2} \psi
$$

- Hence for the Dirac Equation to be consistent with the KG equation require:

$$
\begin{align*}
\alpha_{x}^{2}=\alpha_{y}^{2}=\alpha_{z}^{2}=\beta^{2} & =1  \tag{D2}\\
\alpha_{j} \beta+\beta \alpha_{j} & =0  \tag{D3}\\
\alpha_{j} \alpha_{k}+\alpha_{k} \alpha_{j} & =0 \quad(j \neq k) \tag{D4}
\end{align*}
$$

$\star$ Immediately we see that the $\alpha_{j}$ and $\beta$ cannot be numbers. Require 4 mutually anti-commuting matrices
$\star$ Must be (at least) $4 \times 4$ matrices (see Appendix I)
-Consequently the wave-function must be a four-component Dirac Spinor

$$
\psi=\left(\begin{array}{l}
\psi_{1} \\
\psi_{2} \\
\psi_{3} \\
\psi_{4}
\end{array}\right) \quad \begin{aligned}
& \text { A consequence of introducing an equation } \\
& \text { that is 1st order in time/space derivatives is that } \\
& \text { the wave-function has new degrees of freedom ! }
\end{aligned}
$$

- For the Hamiltonian $\hat{H} \psi=(\vec{\alpha} \cdot \vec{p}+\beta m) \psi=i \partial \psi / \partial t$ to be Hermitian requires

$$
\begin{equation*}
\alpha_{x}=\alpha_{x}^{\dagger} ; \quad \alpha_{y}=\alpha_{y}^{\dagger} ; \quad \alpha_{z}=\alpha_{z}^{\dagger} ; \quad \beta=\beta^{\dagger} ; \tag{D5}
\end{equation*}
$$

i.e. the require four anti-commuting Hermitian $4 \times 4$ matrices.

- At this point it is convenient to introduce an explicit representation for $\vec{\alpha}, \beta$. It should be noted that physical results do not depend on the particular representation - everything is in the commutation relations.
- A convenient choice is based on the Pauli spin matrices:

$$
\beta=\left(\begin{array}{rr}
I & 0 \\
0 & -I
\end{array}\right), \quad \alpha_{j}=\left(\begin{array}{cc}
0 & \sigma_{j} \\
\sigma_{j} & 0
\end{array}\right)
$$

with $I=\left(\begin{array}{ll}1 & 0 \\ 0 & 1\end{array}\right), \quad \sigma_{x}=\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right), \quad \sigma_{y}=\left(\begin{array}{rr}0 & -i \\ i & 0\end{array}\right), \quad \sigma_{z}=\left(\begin{array}{rr}1 & 0 \\ 0 & -1\end{array}\right)$

- The matrices are Hermitian and anti-commute with each other


## Dirac Equation: Probability Density and Current

- Now consider probability density/current - this is where the perceived problems with the Klein-Gordon equation arose.
- Start with the Dirac equation

$$
\begin{equation*}
-i \alpha_{x} \frac{\partial \psi}{\partial x}-i \alpha_{y} \frac{\partial \psi}{\partial y}-i \alpha_{z} \frac{\partial \psi}{\partial z}+m \beta \psi=i \frac{\partial \psi}{\partial t} \tag{D6}
\end{equation*}
$$

and its Hermitian conjugate

$$
\begin{equation*}
+i \frac{\partial \psi^{\dagger}}{\partial x} \alpha_{x}^{\dagger}+i \frac{\partial \psi^{\dagger}}{\partial y} \alpha_{y}^{\dagger}+i \frac{\partial \psi^{\dagger}}{\partial z} \alpha_{z}^{\dagger}+m \psi^{\dagger} \beta^{\dagger}=-i \frac{\partial \psi^{\dagger}}{\partial t} \tag{D7}
\end{equation*}
$$

- Consider $\psi^{\dagger} \times($ D6 $)-(\mathbf{D} 7) \times \psi$ remembering $\alpha, \beta$ are Hermitian
$\psi^{\dagger}\left(-i \alpha_{x} \frac{\partial \psi}{\partial x}-i \alpha_{y} \frac{\partial \psi}{\partial y}-i \alpha_{z} \frac{\partial \psi}{\partial z}+\beta m \psi\right)-\left(i \frac{\partial \psi^{\dagger}}{\partial x} \alpha_{x}+i \frac{\partial \psi^{\dagger}}{\partial y} \alpha_{y}+i \frac{\partial \psi^{\dagger}}{\partial z} \alpha_{z}+m \psi^{\dagger} \beta\right) \psi=i \psi^{\dagger} \frac{\partial \psi}{\partial t}+i \frac{\partial \psi^{\dagger}}{\partial t} \psi$
$\underbrace{\psi^{\dagger}\left(\alpha_{x} \frac{\partial \psi}{\partial x}\right.}+\alpha_{y} \frac{\partial \psi}{\partial y}+\alpha_{z} \frac{\partial \psi}{\partial z})+\underbrace{\left(\frac{\partial \psi^{\dagger}}{\partial x} \alpha_{x}\right.}+\frac{\partial \psi^{\dagger}}{\partial y} \alpha_{y}+\frac{\partial \psi^{\dagger}}{\partial z} \alpha_{z}) \psi+\frac{\partial\left(\psi^{\dagger} \psi\right)}{\partial t}=0$
- Now using the identitv:

$$
\psi^{\dagger} \alpha_{x} \frac{\partial \psi}{\partial x}+\frac{\partial \psi^{\dagger}}{\partial x} \alpha_{x} \psi \equiv \frac{\partial\left(\psi^{\dagger} \alpha_{x} \psi\right)}{\partial x}
$$

gives the continuity equation

$$
\begin{equation*}
\vec{\nabla} \cdot\left(\psi^{\dagger} \vec{\alpha} \psi\right)+\frac{\partial\left(\psi^{\dagger} \psi\right)}{\partial t}=0 \tag{D8}
\end{equation*}
$$

where $\psi^{\dagger}=\left(\psi_{1}^{*}, \psi_{2}^{*}, \psi_{3}^{*}, \psi_{4}^{*}\right)$
-The probability density and current can be identified as:

$$
\rho=\psi^{\dagger} \psi \quad \text { and } \quad \vec{j}=\psi^{\dagger} \vec{\alpha} \psi
$$

where $\rho=\psi^{\dagger} \psi=\left|\psi_{1}\right|^{2}+\left|\psi_{2}\right|^{2}+\left|\psi_{3}\right|^{2}+\left|\psi_{4}\right|^{2}>0$

- Unlike the KG equation, the Dirac equation has probability densities which are always positive.
- In addition, the solutions to the Dirac equation are the four component Dirac Spinors. A great success of the Dirac equation is that these components naturally give rise to the property of intrinsic spin.
- It can be shown that Dirac spinors represent spin-half particles (appendix II) with an intrinsic magnetic moment of

$$
\vec{\mu}=\frac{q}{m} \vec{S}
$$

## Covariant Notation: the Dirac $\gamma$ Matrices

- The Dirac equation can be written more elegantly by introducing the four Dirac gamma matrices:

$$
\gamma^{0} \equiv \beta ; \quad \gamma^{1} \equiv \beta \alpha_{x} ; \quad \gamma^{2} \equiv \beta \alpha_{y} ; \quad \gamma^{3} \equiv \beta \alpha_{z}
$$

Premultiply the Dirac equation (D6) by $\beta$

$$
\begin{aligned}
i \beta \alpha_{x} \frac{\partial \psi}{\partial x}+i \beta \alpha_{y} \frac{\partial \psi}{\partial y}+i \beta \alpha_{z} \frac{\partial \psi}{\partial z}-\beta^{2} m \psi & =-i \beta \frac{\partial \psi}{\partial t} \\
\Rightarrow \quad i \gamma^{1} \frac{\partial \psi}{\partial x}+i \gamma^{2} \frac{\partial \psi}{\partial y}+i \gamma^{3} \frac{\partial \psi}{\partial z}-m \psi & =-i \gamma^{0} \frac{\partial \psi}{\partial t}
\end{aligned}
$$

using $\quad \partial_{\mu}=\left(\frac{\partial}{\partial t}, \frac{\partial}{\partial x}, \frac{\partial}{\partial y}, \frac{\partial}{\partial z}\right) \quad$ this can be written compactly as:

$$
\begin{equation*}
\left(i \gamma^{\mu} \partial_{\mu}-m\right) \psi=0 \tag{D9}
\end{equation*}
$$

NOTE: it is important to realise that the Dirac gamma matrices are not four-vectors - they are constant matrices which remain invariant under a Lorentz transformation. However it can be shown that the Dirac equation is itself Lorentz covariant (see Appendix IV)

## Properties of the $\gamma$ matrices

- From the properties of the $\alpha$ and $\beta$ matrices (D2)-(D4) immediately obtain:

$$
\left(\gamma^{0}\right)^{2}=\beta^{2}=1 \quad \text { and } \quad\left(\gamma^{1}\right)^{2}=\beta \alpha_{x} \beta \alpha_{x}=-\alpha_{x} \beta \beta \alpha_{x}=-\alpha_{x}^{2}=-1
$$

-The full set of relations is

$$
\begin{aligned}
\left(\gamma^{1}\right)^{2}=\left(\gamma^{2}\right)^{2}=\left(\gamma^{3}\right)^{2} & =-1 \\
\gamma^{0} \gamma^{j}+\gamma^{j} \gamma^{0} & =0 \\
\gamma^{j} \gamma^{k}+\gamma^{k} \gamma^{j} & =0 \quad(j \neq k)
\end{aligned}
$$

which can be expressed as:

$$
\left\{\gamma^{\mu}, \gamma^{\nu}\right\}=\gamma^{\mu} \gamma^{\nu}+\gamma^{\nu} \gamma^{\mu}=2 g^{\mu \nu} \quad \text { (defines the algebra) }
$$

- Are the gamma matrices Hermitian?
- $\beta$ is Hermitian so $\gamma^{0}$ is Hermitian.
- The $\alpha$ matrices are also Hermitian, giving

$$
\gamma^{1 \dagger}=\left(\beta \alpha_{x}\right)^{\dagger}=\alpha_{x}^{\dagger} \beta^{\dagger}=\alpha_{x} \beta=-\beta \alpha_{x}=-\gamma^{1}
$$

- Hence $\gamma^{1}, \gamma^{2}, \gamma^{3}$ are anti-Hermitian

$$
\gamma^{0 \dagger}=\gamma^{0}, \quad \gamma^{1 \dagger}=-\gamma^{1}, \gamma^{2 \dagger}=-\gamma^{2}, \quad \gamma^{3 \dagger}=-\gamma^{3}
$$

## Pauli-Dirac Representation

- From now on we will use the Pauli-Dirac representation of the gamma matrices:

$$
\gamma^{0}=\left(\begin{array}{rr}
I & 0 \\
0 & -I
\end{array}\right) ; \quad \gamma^{k}=\left(\begin{array}{cc}
0 & \sigma_{k} \\
-\sigma_{k} & 0
\end{array}\right) \quad \text { which when written in full are }
$$

$$
\gamma^{0}=\left(\begin{array}{cccc}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & -1 & 0 \\
0 & 0 & 0 & -1
\end{array}\right) ; \gamma^{1}=\left(\begin{array}{rrrr}
0 & 0 & 0 & 1 \\
0 & 0 & 1 & 0 \\
0 & -1 & 0 & 0 \\
-1 & 0 & 0 & 0
\end{array}\right) ; \gamma^{2}=\left(\begin{array}{cccc}
0 & 0 & 0 & -i \\
0 & 0 & i & 0 \\
0 & i & 0 & 0 \\
-i & 0 & 0 & 0
\end{array}\right) ; \gamma^{3}=\left(\begin{array}{cccc}
0 & 0 & 1 & 0 \\
0 & 0 & 0 & -1 \\
-1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0
\end{array}\right)
$$

- Using the gamma matrices $\rho=\psi^{\dagger} \psi$ and $\vec{j}=\psi^{\dagger} \vec{\alpha} \psi$ can be written as:

$$
j^{\mu}=(\rho, \vec{j})=\psi^{\dagger} \gamma^{0} \gamma^{\mu} \psi
$$

where $j^{\mu}$ is the four-vector current.
(The proof that $j^{\mu}$ is indeed a four vector is given in Appendix V.)

- In terms of the four-vector current the continuity equation becomes

$$
\partial_{\mu} j^{\mu}=0
$$

- Finally the expression for the four-vector current

$$
j^{\mu}=\psi^{\dagger} \gamma^{0} \gamma^{\mu} \psi
$$

can be simplified by introducing the adjoint spinor

## The Adjoint Spinor

- The adjoint spinor is defined as

$$
\bar{\psi}=\psi^{\dagger} \gamma^{0}
$$

i.e. $\bar{\psi}=\psi^{\dagger} \gamma^{0}=\left(\psi^{*}\right)^{T} \gamma^{0}=\left(\psi_{1}^{*}, \psi_{2}^{*}, \psi_{3}^{*}, \psi_{4}^{*}\right)\left(\begin{array}{cccc}1 & 0 & 0 & 0 \\ 0 & 1 & 0 & 0 \\ 0 & 0 & -1 & 0 \\ 0 & 0 & 0 & -1\end{array}\right)$

$$
\bar{\psi}=\left(\psi_{1}^{*}, \psi_{2}^{*},-\psi_{3}^{*},-\psi_{4}^{*}\right)
$$

- In terms the adjoint spinor the four vector current can be written:

$$
j^{\mu}=\bar{\psi} \gamma^{\mu} \psi
$$

$\star$ We will use this expression in deriving the Feynman rules for the Lorentz invariant matrix element for the fundamental interactions.
*That's enough notation, start to investigate the free particle solutions of the Dirac equation...

## Dirac Equation: Free Particle at Rest

- Look for free particle solutions to the Dirac equation of form:

$$
\psi=u(E, \vec{p}) e^{i(\vec{p} \cdot \vec{r}-E t)}
$$

where $u(\vec{p}, E)$, which is a constant four-component spinor which must satisfy the Dirac equation

$$
\left(i \gamma^{\mu} \partial_{\mu}-m\right) \psi=0
$$

- Consider the derivatives of the free particle solution

$$
\partial_{0} \psi=\frac{\partial \psi}{\partial t}=-i E \psi ; \quad \partial_{1} \psi=\frac{\partial \psi}{\partial x}=i p_{x} \psi, \quad \ldots
$$

substituting these into the Dirac equation gives:

$$
\left(\gamma^{0} E-\gamma^{1} p_{x}-\gamma^{2} p_{y}-\gamma^{3} p_{z}-m\right) u=0
$$

which can be written:

$$
\begin{equation*}
\left(\gamma^{\mu} p_{\mu}-m\right) u=0 \tag{D10}
\end{equation*}
$$

- This is the Dirac equation in "momentum" - note it contains no derivatives.
- For a particle at rest $\vec{p}=0$
and $\quad \psi=u(E, 0) e^{-i E t}$
eq. (D10)
$E \gamma^{0} u-m u=0$

$$

still have NEGATIVE ENERGY SOLUTIONS
(Question 6)

- Including the time dependence from $\psi=u(E, 0) e^{-i E t}$ gives
$\psi_{1}=\underbrace{\left(\begin{array}{l}1 \\ 0 \\ 0 \\ 0\end{array}\right) e^{-i m t} ; \quad \psi_{2}=\left(\begin{array}{l}0 \\ 1 \\ 0 \\ 0\end{array}\right) e^{-i m t}}_{\text {Two spin states with E>0 }} ; \quad \psi_{3}=\underbrace{\left(\begin{array}{l}0 \\ 0 \\ 1 \\ 0\end{array}\right) e^{+i m t} ; \text { and } \psi_{4}=\left(\begin{array}{l}0 \\ 0 \\ 0 \\ 1\end{array}\right)}_{\text {Two spin states with E<0 }} e^{+i m t}$
$\star$ In QM mechanics can't just discard the $\mathrm{E}<0$ solutions as unphysical as we require a complete set of states - i.e. 4 SOLUTIONS


## Dirac Equation: Plane Wave Solutions

- Now aim to find general plane wave solutions: $\quad \psi=u(E, \vec{p}) e^{i(\vec{p} \cdot \vec{r}-E t)}$
- Start from Dirac equation (D10): $\left(\gamma^{\mu} p_{\mu}-m\right) u=0$
and use $\gamma^{\mu} p_{\mu}-m=E \gamma^{0}-p_{x} \gamma^{1}-p_{y} \gamma^{2}-p_{z} \gamma^{3}-m$

$$
\begin{aligned}
& =\left(\begin{array}{cc}
I & 0 \\
0 & -I
\end{array}\right) E-\left(\begin{array}{cc}
0 & \vec{\sigma} \\
-\vec{\sigma} & 0
\end{array}\right) \cdot \vec{p}-m\left(\begin{array}{ll}
I & 0 \\
0 & I
\end{array}\right) \\
& \left.=\binom{\left(\begin{array}{c}
E-m) I \\
\vec{\sigma} \cdot \vec{p}
\end{array}-(\vec{\sigma} \cdot \vec{p}\right.}{\hline} \begin{array}{c}
\text { Note } \\
\vec{\sigma} \cdot \vec{p}
\end{array}\right) p_{x} \sigma_{x}+p_{y} \sigma_{y}+p_{z} \sigma_{z}
\end{aligned}
$$

Note in the above equation the $4 \times 4$ matrix is written in terms of four $\mathbf{2 x 2}$ sub-matrices
-Writing the four component spinor as

$$
u=\binom{u_{A}}{u_{B}}
$$

$$
\left.\begin{array}{l}
\left(\gamma^{\mu} p_{\mu}-m\right) u=0 \Rightarrow\left(\begin{array}{cc}
(E-m) I & -\vec{\sigma} \cdot \vec{p} \\
\vec{\sigma} \cdot \vec{p} & (-E-m) I
\end{array}\right)\binom{u_{A}}{u_{B}}=\binom{0}{0} \\
\begin{array}{l}
\text { Giving two coupled } \\
\text { simultaneous equations } \\
\text { for } u_{A}, u_{B}
\end{array} \\
(\vec{\sigma} \cdot \vec{p}) u_{B}=(E-m) u_{A} \\
(\vec{\sigma} \cdot \vec{p}) u_{A}=(E+m) u_{B}
\end{array}\right\}
$$

Expanding $\quad \vec{\sigma} \cdot \vec{p}=\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right) p_{x}+\left(\begin{array}{rr}0 & -i \\ i & 0\end{array}\right) p_{y}+\left(\begin{array}{rr}1 & 0 \\ 0 & -1\end{array}\right) p_{z}$

$$
\vec{\sigma} \cdot \vec{p}=\left(\begin{array}{cc}
p_{z} & p_{x}-i p_{y} \\
p_{x}+i p_{y} & -p_{z}

-Therefore (D12)

- Solutions can be obtained by making the arbitrary (but simplest) choices for $u_{A}$

giving $\quad u_{1}=N_{1}\left(\begin{array}{c}1 \\ 0 \\ \frac{p_{z}}{E+m} \\ \frac{x_{x}+i p_{y}}{E+m}\end{array}\right) ; \quad$ and $\quad u_{2}=N_{2}\left(\begin{array}{c}0 \\ 1 \\ \frac{p_{x}-i p_{y}}{E+m} \\ \frac{-p_{z}}{E+m}\end{array}\right)$
where $\mathbf{N}$ is the wave-function normalisation

NOTE: For $\vec{p}=0$ these correspond to the $\mathrm{E}>0$ particle at rest solutions $\star$ The choice of $u_{A}$ is arbitrary, but this isn't an issue since we can express any other choice as a linear combination. It is analogous to choosing a basis for spin which could be eigenfunctions of $\mathbf{S}_{\mathrm{x}}, \mathrm{S}_{\mathrm{y}}$ or $\mathbf{S}_{\mathbf{z}}$

Repeating for $u_{B}=\binom{1}{0}$ and $u_{B}=\binom{0}{1}$ gives the solutions $u_{3}$ and $u_{4}$
$\star$ The four solutions are: $\psi_{i}=u_{i}(E, \vec{p}) e^{i(\vec{p} \cdot \vec{r}-E t)}$

$$

- If any of these solutions is put back into the Dirac equation, as expected, we obtain

$$
E^{2}=\vec{p}^{2}+m^{2}
$$

which doesn't in itself identify the negative energy solutions.

- One rather subtle point: One could ask the question whether we can interpret
all four solutions as positive energy solutions. The answer is no. If we take
all solutions to have the same value of $E$, i.e. $E=+|E|$, only two of the solutions
are found to be independent.
-There are only four independent solutions when the two are taken to have $E<0$.
$\star$ To identify which solutions have $\mathrm{E}<0$ energy refer back to particle at rest (eq. D11 ).
- For $\vec{p}=0: \quad u_{1}, u_{2}$ correspond to the $\mathrm{E}>0$ particle at rest solutions $u_{3}, u_{4}$ correspond to the $\mathrm{E}<0$ particle at rest solutions


## Interpretation of -ve Energy Solutions

$\star$ The Dirac equation has negative energy solutions. Unlike the KG equation these have positive probability densities. But how should -ve energy solutions be interpreted? Why don't all +ve energy electrons fall into to the lower energy -ve energy states?

Dirac Interpretation: the vacuum corresponds to all -ve energy states being full with the Pauli exclusion principle preventing electrons falling into -ve energy states. Holes in the -ve energy states correspond to +ve energy anti-particles with opposite charge. Provides a picture for pair-production and annihilation.


$$
\gamma \rightarrow \mathrm{e}^{-} \mathrm{e}^{+}
$$



## Discovery of the Positron

$\star$ Cosmic ray track in cloud chamber:


- $\mathbf{e}^{+}$enters at bottom, slows down in the lead plate - know direction
- Curvature in B-field shows that it is a positive particle
- Can't be a proton as would have stopped in the lead

Provided Verification of Predictions of Dirac Equation

* Anti-particle solutions exist! But the picture of the vacuum corresponding to the state where all -ve energy states are occupied is rather unsatisfactory, what about bosons (no exclusion principle),....


## Feynman-Stückelberg Interpretation

*There are many problems with the Dirac interpretation of anti-particles and it is best viewed as of historical interest - don't take it too seriously.

## Feynman-Stückelberg Interpretation:

* Interpret a negative energy solution as a negative energy particle which propagates backwards in time or equivalently a positive energy anti-particle which propagates forwards in time


$$
e^{-i(-E)(-t)} \rightarrow e^{-i E t}
$$

$\mathrm{e}^{-}{ }_{(\mathrm{E}<0)}$

NOTE: in the Feynman diagram the arrow on the anti-particle remains in the backwards in time direction to label it an anti-particle solution.
$\star$ At this point it become more convenient to work with anti-particle wave-functions with $E=\sqrt{|\vec{p}|^{2}+m^{2}}$ motivated by this interpretation

## Anti-Particle Spinors

- Want to redefine our -ve energy solutions such that: $E=\left|\sqrt{|\vec{p}|^{2}+m^{2}}\right|$
i.e. the energy of the physical anti-particle.


## We can look at this in two ways:

1 Start from the negative energy solutions

$$
u_{3}=N_{3}\left(\begin{array}{c}
\frac{p_{z}}{E-m} \\
\frac{p_{x}+i p_{y}}{E-m} \\
1 \\
0
\end{array}\right) ; u_{4}=N_{4}\left(\begin{array}{c}
\frac{p_{x}-i p_{y}}{E-m} \\
\frac{-p_{z}}{E-m} \\
0 \\
1
\end{array}\right)
$$

Where $E$ is understood to be negative

- Can simply "define" anti-particle wave-function by flipping the sign of $E$ and $\vec{p}$ following the Feynman-Stückelburg interpretation:

$$
\begin{aligned}
& v_{1}(E, \vec{p}) e^{-i(\vec{p} \cdot \vec{r}-E t)}=u_{4}(-E,-\vec{p}) e^{i(\vec{p} \cdot \vec{r}-E t)} \\
& v_{2}(E, \vec{p}) e^{-i(\vec{p} \cdot \vec{r}-E t)}=u_{3}(-E,-\vec{p}) e^{i(\vec{p} \cdot \vec{r}-E t)}
\end{aligned}
$$

where $E$ is now understood to be positive, $E=\left|\sqrt{|\vec{p}|^{2}+m^{2}}\right|$

## Anti-Particle Spinors

(2) Find negative energy plane wave solutions to the Dirac equation of the form: $\psi=v(E, \vec{p}) e^{-i\langle\vec{p} \cdot \vec{r}-E t)} \quad$ where $\quad E=\left|\sqrt{|\vec{p}|^{2}+m^{2}}\right|$

- Note that although $E>0$ these are still negative energy solutions in the sense that $\quad \hat{H} v_{1}=i \frac{\partial}{\partial t} v_{1}=-E v_{1}$
- Solving the Dirac equation $\left(i \gamma^{\mu} \partial_{\mu}-m\right) \psi=0$

$$
\begin{gather*}
\Rightarrow \quad\left(-\gamma^{0} E+\gamma^{1} p_{x}+\gamma^{2} p_{y}+\gamma^{3} p_{z}-m\right) v=0 \\
\left(\gamma^{\mu} p_{\mu}+m\right) v=0 \tag{D13}
\end{gather*}
$$

* The Dirac equation in terms of momentum for ANTI-PARTICLES
-Proceeding as before: $\left.\quad(\vec{\sigma} \cdot \vec{p}) v_{A}=(E-m) v_{B}\right\} \quad$ etc., ...

$$
(\vec{\sigma} \cdot \vec{p}) v_{B}=(E+m) v_{A}
$$

$$
v_{1}=N_{1}^{\prime}\left(\begin{array}{c}
\frac{p_{x}-i p_{y}}{E+m} \\
\frac{-p_{z}}{E+m} \\
0 \\
1
\end{array}\right) ; \quad v_{2}=N_{2}^{\prime}\left(\begin{array}{c}

## Wave-Function Normalisation

-From handout 1 want to normalise wave-functions to $2 E$ particles per unit volume
-Consider

$$
\psi=u_{1} e^{+i(\vec{p} \cdot \vec{r}-E t)}
$$

Probability density

$$
\rho=\psi^{\dagger} \psi=\left(\psi^{*}\right)^{T} \psi=u_{1}^{\dagger} u_{1}
$$

$$
\begin{aligned}
u_{1}^{\dagger} u_{1} & =|N|^{2}\left(1+\frac{p_{z}^{2}}{(E+m)^{2}}+\frac{p_{x}^{2}+p_{y}^{2}}{(E+m)^{2}}\right) \\
& =|N|^{2}\left(\frac{(E+m)^{2}+|\vec{p}|^{2}}{(E+m)^{2}}\right)=|N|^{2}\left(\frac{(E+m)^{2}+E^{2}-m^{2}}{(E+m)^{2}}\right) \\
& =|N|^{2} \frac{2 E^{2}+2 E m}{(E+m)^{2}}=|N|^{2} \frac{2 E}{E+m}
\end{aligned}
$$

which for the desired $2 E$ particles per unit volume, requires that

N=\sqrt{E+m}
$$

- Obtain same value of $\boldsymbol{N}$ for $u_{1}, u_{2}, v_{1}, v_{2}$


## Charge Conjugation

- In the part II Relativity and Electrodynamics course it was shown that the motion of a charged particle in an electromagnetic field $A^{\mu}=(\phi, \vec{A})$
can be obtained by making the minimal substitution
with

$$
\vec{p} \rightarrow \vec{p}-e \vec{A} ; \quad E \rightarrow E-e \phi
$$

this can be written

$$
\vec{p}=-i \vec{\nabla} ; \quad E=i \partial / \partial t
$$

and the Dirac equation becomes:

$$
\gamma^{\mu}\left(\partial_{\mu}+i e A_{\mu}\right) \psi+i m \psi=0
$$

-Taking the complex conjugate and pre-multiplying by $-i \gamma^{2}$

$$
\Rightarrow \quad-i \gamma^{2} \gamma^{\mu *}\left(\partial_{\mu}-i e A_{\mu}\right) \psi^{*}-m \gamma^{2} \psi^{*}=0
$$

But $\quad \gamma^{0 *}=\gamma^{0} ; \gamma^{1 *}=\gamma^{1} ; \gamma^{2 *}=-\gamma^{2} ; \gamma^{3 *}=\gamma^{3} \quad$ and $\quad \gamma^{2} \gamma^{\mu *}=-\gamma^{\mu} \gamma^{2}$

$$
\begin{equation*}
\Rightarrow \quad \gamma^{\mu}\left(\partial_{\mu}-i e A_{\mu}\right) \underbrace{\gamma^{2} \psi^{*}}+i m \underbrace{\gamma^{2} \psi^{*}}=0 \tag{D14}
\end{equation*}
$$

- Define the charge conjugation operator:

$$
\psi^{\prime}=\hat{C} \psi=i \gamma^{2} \psi^{*}
$$

D14 becomes:

$$
\gamma^{\mu}\left(\partial_{\mu}-i e A_{\mu}\right) \psi^{\prime}+i m \psi^{\prime}=0
$$

- Comparing to the original equation

$$
\gamma^{\mu}\left(\partial_{\mu}+i e A_{\mu}\right) \psi+i m \psi=0
$$

we see that the spinor $\psi^{\prime}$ describes a particle of the same mass but with opposite charge, i.e. an anti-particle!

$$
\hat{C} \Rightarrow \text { particle spinor } \leftrightarrow \text { anti-particle spinor }
$$

- Now consider the action of $\hat{C}$ on the free particle wave-function:

$$
\begin{gathered}
\psi=u_{1} e^{i(\vec{p} \cdot \vec{r}-E t)} \\
\psi^{\prime}=\hat{C} \psi=i \gamma^{2} \psi^{*}=i \gamma^{2} u_{1}^{*} e^{-i(\vec{p} \cdot \vec{r}-E t)} \\
i \gamma^{2} u_{1}^{*}=i\left(\begin{array}{cccc}
0 & 0 & 0 & -i \\
0 & 0 & i & 0 \\
0 & i & 0 & 0 \\
-i & 0 & 0 & 0
\end{array}\right) \sqrt{E+m}\left(\begin{array}{c}
1 \\
0 \\
\frac{p_{z}}{E+m} \\
\frac{p_{x}+i p_{y}}{E+m}
\end{array}\right)=\sqrt{E+m}\left(\begin{array}{c}
\frac{p_{x}-i p_{y}}{E+m} \\

hence

$$
\text { similarly } \quad \psi=u_{2} e^{i(\vec{p} \cdot \vec{r}-E t)} \xrightarrow{\hat{C}} \psi^{\prime}=v_{2} e^{-i(\vec{p} \cdot \vec{r}-E t)}
$$

$\star$ Under the charge conjugation operator the particle spinors $u_{1}$ and $u_{2}$ transform to the anti-particle spinors $v_{1}$ and $v_{2}$

## Using the anti-particle solutions

-There is a subtle but important point about the anti-particle solutions written as

$$
\psi=v(E, \vec{p}) e^{-i(\vec{p} \cdot \vec{r}-E t)}
$$

Applying normal QM operators for momentum and energy $\hat{p}=-i \vec{\nabla}, \quad \hat{H}=i \partial / \partial t$ gives $\quad \hat{H} v_{1}=i \partial v_{1} / \partial t=-E v_{1} \quad$ and $\quad \hat{p} v_{1}=-i \vec{\nabla} v_{1}=-\vec{p} v_{1}$
$\star$ But have defined solutions to have $\mathrm{E}>0$
夫 Hence the quantum mechanical operators giving the physical energy and momenta of the anti-particle solutions are:

$$
\hat{H}^{(v)}=-i \partial / \partial t \quad \text { and } \quad \hat{p}^{(v)}=i \vec{\nabla}
$$

- Under the transformation $(E, \vec{p}) \rightarrow(-E,-\vec{p}): \vec{L}=\vec{r} \wedge \vec{p} \rightarrow-\vec{L}$

Conservation of total angular momentum $[H, \vec{L}+\vec{S}]=0 \quad \Longrightarrow \quad \hat{S}^{(v)} \rightarrow-\hat{S}$
$\star$ The physical spin of the anti-particle solutions is given by $\hat{S}^{(v)}=-\hat{S}$

In the hole picture:


A spin-up hole leaves the negative energy sea in a spin down state

## Summary of Solutions to the Dirac Equation

- The normalised free PARTICLE solutions to the Dirac equation:

For these states the spin is given by $\hat{S}^{(v)}=-\hat{S}$

- For both particle and anti-particle solutions: $E=\sqrt{|\vec{p}|^{2}+m^{2}}$
(Now try question 7 - mainly about 4 vector current )


## Spin States

- In general the spinors $u_{1}, u_{2}, v_{1}, v_{2}$ are not Eigenstates of $\hat{S}_{z}$

$\star$ Spinors $u_{1}, u_{2}, v_{1}, v_{2}$ are only eigenstates of $\hat{S}_{z}$ for $p_{z}= \pm|\vec{p}|$

## Pause for Breath...

- Have found solutions to the Dirac equation which are also eigenstates $\hat{S}_{z}$ but only for particles travelling along the $z$ axis.
- Not a particularly useful basis
- More generally, want to label our states in terms of "good quantum numbers", i.e. a set of commuting observables.
- Can't use $z$ component of spin: $\left[\hat{H}, \hat{S}_{z}\right] \neq 0 \quad$ (Appendix II)
- Introduce a new concept "HELICITY"

Helicity plays an important role in much that follows

## Helicity

* The component of a particles spin along its direction of flight is a good quantum number:

$$
[\hat{H}, \hat{S} . \hat{p}]=0
$$

* Define the component of a particles spin along its direction of flight as HELICITY:

$$
h \equiv \frac{\vec{S} \cdot \vec{p}}{|\vec{S}||\vec{p}|}=\frac{2 \vec{S} \cdot \vec{p}}{|\vec{p}|}=\frac{\vec{\Sigma} \cdot \vec{p}}{|\vec{p}|}
$$



- If we make a measurement of the component of spin of a spin-half particle along any axis it can take two values $\pm 1 / 2$, consequently the eigenvalues of the helicity operator for a spin-half particle are: $\pm 1$

Often termed: "right-handed"

"left-handed"

* NOTE: these are "RIGHT-HANDED" and LEFT-HANDED HELICITY eigenstates夫 In handout 4 we will discuss RH and LH CHIRAL eigenstates. Only in the limit $v \approx c$ are the HELICITY eigenstates the same as the CHIRAL eigenstates


## Helicity Eigenstates

$\star$ Wish to find solutions of Dirac equation which are also eigenstates of Helicity:

$$
(\vec{\Sigma} . \hat{p}) u_{\uparrow}=+u_{\uparrow} \quad(\vec{\Sigma} . \hat{p}) u_{\downarrow}=-u_{\downarrow}
$$

where $u_{\uparrow}$ and $u_{\downarrow}$ are right and left handed helicity states and here $\hat{p}$ is the unit vector in the direction of the particle.
-The eigenvalue equation:

$$

\vec{\sigma} \cdot \hat{p} & 0 \\
0 & \vec{\sigma} \cdot \hat{p}
\end{array}\right)\binom{u_{A}}{u_{B}}= \pm\binom{ u_{A}}{u_{B}}

gives the coupled equations:

(\vec{\sigma} \cdot \hat{p}) u_{A}= \pm u_{A}  \tag{D15}\\
(\vec{\sigma} \cdot \hat{p}) u_{B}= \pm u_{B}
\end{array}\right\}
$$

- Consider a particle propagating in $(\theta, \phi)$ direction

$$
\hat{p}=(\sin \theta \cos \phi, \sin \theta \sin \phi, \cos \theta)
$$


$\vec{\sigma} \cdot \hat{p}=\left(\begin{array}{cc}p_{z} & p_{x}-i p_{y} \\ p_{x}+i p_{y} & -p_{z}\end{array}\right)=\left(\begin{array}{cc}\cos \theta & \sin \theta \cos \phi-i \sin \theta \sin \phi \\ \sin \theta \cos \phi+i \sin \theta \sin \phi & -\cos \theta\end{array}\right)$

$$
\vec{\sigma} \cdot \hat{p}=\left(\begin{array}{cc}
\cos \theta & \sin \theta e^{-i \phi} \\
\sin \theta e^{i \phi} & -\cos \theta
\end{array}\right)
$$

-Writing either $u_{A}=\binom{a}{b}$ or $u_{B}=\binom{a}{b}$ then (D15) gives the relation

So for the components of BOTH $u_{A}$ and $u_{B}$

-For the right-handed helicity state, i.e. helicity +1 :

& \frac{b}{a}= \frac{1-\cos \theta}{\sin \theta} e^{i \phi}=\frac{2 \sin ^{2}\left(\frac{\theta}{2}\right)}{2 \sin \left(\frac{\theta}{2}\right) \cos \left(\frac{\theta}{2}\right)} e^{i \phi}=e^{i \phi} \frac{\sin \left(\frac{\theta}{2}\right)}{\cos \left(\frac{\theta}{2}\right)} \\
& \longrightarrow \quad u_{A \uparrow} \propto\binom{\cos \left(\frac{\theta}{2}\right)}{e^{i \phi} \sin \left(\frac{\theta}{2}\right)}
\end{aligned}
$$

-Putting in the constants of proportionality gives:

$$
u_{\uparrow}=\binom{u_{A}}{u_{B}}=\left(\begin{array}{c}
\kappa_{1} \cos \left(\frac{\theta}{2}\right) \\
\kappa_{1} e^{i \phi} \sin \left(\frac{\theta}{2}\right) \\
\kappa_{2} \cos \left(\frac{\theta}{2}\right) \\
\kappa_{2} e^{i \phi} \sin \left(\frac{\theta}{2}\right)
\end{array}\right)
$$

- From the Dirac Equation (D12) we also have

$$
u_{B}=\frac{\vec{\sigma} \cdot \vec{p}}{E+m} u_{A}=\frac{(\vec{\sigma} \cdot \vec{p}) u_{A}=(E+m) u_{B}}{E+m}(\underbrace{\stackrel{\rightharpoonup}{\sigma} \cdot \hat{p})}_{\underbrace{}_{\text {Helicity }}} u_{A}= \pm \frac{|\vec{p}|}{E+m} u_{A}
$$

$\star$ (D15) determines the relative normalisation of $u_{A}$ and $u_{B}$, i.e. here

$$
\begin{gathered}
u_{B}=+1 \frac{|\vec{p}|}{E+m} u_{A} \\
\longrightarrow \quad u_{\uparrow}=N\left(\begin{array}{c}
\cos \left(\frac{\theta}{2}\right) \\
e^{i \phi} \sin \left(\frac{\theta}{2}\right) \\
\frac{|\vec{p}|}{E+m} \cos \left(\frac{\theta}{2}\right) \\
\frac{|\vec{p}|}{E+m} e^{i \phi} \sin \left(\frac{\theta}{2}\right)
\end{array}\right)
\end{gathered}
$$

-The negative helicity particle state is obtained in the same way.
-The anti-particle states can also be obtained in the same manner although it must be remembered that $\hat{S}^{(v)}=-\hat{S}$

$$

* The particle and anti-particle helicity eigenstates states are:

For all four states, normalising to $2 E$ particles/Volume again gives $N=\sqrt{E+m}$

## Intrinsic Parity of Dirac Particles

$\star$ Before leaving the Dirac equation, consider parity
$\star$ The parity operation is defined as spatial inversion through the origin:

$$
x^{\prime} \equiv-x ; \quad y^{\prime} \equiv-y ; \quad z^{\prime} \equiv-z ; \quad t^{\prime} \equiv t
$$

- Consider a Dirac spinor, $\psi(x, y, z, t)$, which satisfies the Dirac equation

\begin{equation*}
i \gamma^{1} \frac{\partial \psi}{\partial x}+i \gamma^{2} \frac{\partial \psi}{\partial y}+i \gamma^{3} \frac{\partial \psi}{\partial z}-m \psi=-i \gamma^{0} \frac{\partial \psi}{\partial t} \tag{D17}
\end{equation*}
$$

- Under the parity transformation: $\quad \psi^{\prime}\left(x^{\prime}, y^{\prime}, z^{\prime}, t^{\prime}\right)=\hat{P} \psi(x, y, z, t)$

Try $\hat{P}=\gamma^{0} \quad \psi^{\prime}\left(x^{\prime}, y^{\prime}, z^{\prime}, t^{\prime}\right)=\gamma^{0} \psi(x, y, z, t)$

$$
\left(\gamma^{0}\right)^{2}=1 \quad \text { so } \quad \psi(x, y, z, t)=\gamma^{0} \psi^{\prime}\left(x^{\prime}, y^{\prime}, z^{\prime}, t^{\prime}\right)
$$

(D17)

- Expressing derivatives in terms of the primed system:

-i \gamma^{1} \gamma^{0} \frac{\partial \psi^{\prime}}{\partial x^{\prime}}-i \gamma^{2} \gamma^{0} \frac{\partial \psi^{\prime}}{\partial y^{\prime}}-i \gamma^{3} \gamma^{0} \frac{\partial \psi^{\prime}}{\partial z^{\prime}}-m \gamma^{0} \psi^{\prime}=-i \gamma^{0} \gamma^{0} \frac{\partial \psi^{\prime}}{\partial t^{\prime}}
$$

Since $\gamma^{0}$ anti-commutes with $\gamma^{1}, \gamma^{2}, \gamma^{3}$ :

+i \gamma^{0} \gamma^{1} \frac{\partial \psi^{\prime}}{\partial x^{\prime}}+i \gamma^{0} \gamma^{2} \frac{\partial \psi^{\prime}}{\partial y^{\prime}}+i \gamma^{0} \gamma^{3} \frac{\partial \psi^{\prime}}{\partial z^{\prime}}-m \gamma^{0} \psi^{\prime}=-i \frac{\partial \psi^{\prime}}{\partial t^{\prime}}
$$

Pre-multiplying by $\gamma^{0} \Rightarrow i \gamma^{1} \frac{\partial \psi^{\prime}}{\partial x^{\prime}}+i \gamma^{2} \frac{\partial \psi^{\prime}}{\partial y^{\prime}}+i \gamma^{3} \frac{\partial \psi^{\prime}}{\partial z^{\prime}}-m \psi^{\prime}=-i \gamma^{0} \frac{\partial \psi^{\prime}}{\partial t^{\prime}}$
-Which is the Dirac equation in the new coordinates.
$\star$ There for under parity transformations the form of the Dirac equation is unchanged provided Dirac spinors transform as

$$
\psi \rightarrow \hat{P} \psi= \pm \gamma^{0} \psi
$$

(note the above algebra doesn't depend on the choice of $\hat{P}= \pm \gamma^{0}$ )
-For a particle/anti-particle at rest the solutions to the Dirac Equation are:

$$
\psi=u_{1} e^{-i m t} ; \psi=u_{2} e^{-i m t} ; \psi=v_{1} e^{+i m t} ; \psi=v_{2} e^{+i m t}
$$

with

$$
u_{1}=N\left(\begin{array}{l}

\end{array}\right) ; \quad u_{2}=N\left(\begin{array}{l}
0 \\

\end{array}\right) ; \quad v_{2}=N\left(\begin{array}{l}
0 \\

$$

$$
\hat{P} u_{1}= \pm\left(\begin{array}{rrrr}

0 & 1 & 0 & 0 \\
0 & 0 & -1 & 0 \\
0 & 0 & 0 & -1
\end{array}\right)\left(\begin{array}{l}

& \hat{P} u_{1}= \pm u_{1} \\

$\star$ Hence an anti-particle at rest has opposite intrinsic parity to a particle at rest.
$\star$ Convention: particles are chosen to have +ve parity; corresponds to choosing

\hat{P}=+\gamma^{0}
$$

## Summary

$\star$ The formulation of relativistic quantum mechanics starting from the linear Dirac equation

$$
\hat{H} \psi=(\vec{\alpha} \cdot \vec{p}+\beta m) \psi=i \frac{\partial \psi}{\partial t}

New degrees of freedom : found to describe Spin $1 / 2$ particles

* In terms of $4 \times 4$ gamma matrices the Dirac Equation can be written:

Starting from $\hat{H} \psi=(\vec{\alpha} \cdot \vec{p}+\beta m) \psi=i \frac{\partial \psi}{\partial t}$

For $\hat{H}$ to be Hermitian for all $\vec{p}$ requires $\alpha_{i}=\alpha_{i}^{\dagger} \quad \beta=\beta^{\dagger}$
To recover the KG equation: $\alpha_{x}^{2}=\alpha_{y}^{2}=\alpha_{z}^{2}=\beta^{2}=1$

\begin{aligned}
\beta \alpha_{j}+\alpha_{j} \beta & =0 \\
\alpha_{j} \alpha_{k}+\alpha_{k} \alpha_{j} & =0 \quad(j \neq k)
\end{aligned}
$$

Consider

\operatorname{Tr}\left(B^{\dagger} A B\right)=B_{i j}^{\dagger} A_{j k} B_{k i}
$$

with $B^{\dagger} B=1$

We can now show that the matrices are of even dimension by considering the eigenvalue equation, e.g. $\alpha \vec{x}=\lambda \vec{x}$

Eigenvalues of a Hermitian matrix are real so $\lambda^{2}=1 \quad \rightarrow \lambda= \pm 1$ but

Since the $\alpha_{i}, \beta$ are trace zero Hermitian matrices with eigenvalues of $\pm 1$ they must be of even dimension

For $\mathbf{N}=\mathbf{2}$ the 3 Pauli spin matrices satisfy

$$
\sigma_{i} \sigma_{j}+\sigma_{j} \sigma_{i}=0 \quad(j \neq i)
$$

But we require 4 anti-commuting matrices. Consequently the $\alpha_{i}, \beta$ of the Dirac equation must be of dimension 4, 6, 8,..... The simplest choice for is to assume that the $\alpha_{i}, \beta$ are of dimension 4.

-For a Dirac spinor is orbital angular momentum a good quantum number?
i.e. does $L=\vec{r} \wedge \vec{p}$ commute with the Hamiltonian?

The only non-zero contributions come from: $\left[x, p_{x}\right]=\left[y, p_{y}\right]=\left[z, p_{z}\right]=i$

{\left[H, L_{x}\right] } & =\alpha_{y} p_{z}\left[p_{y}, y\right]-\alpha_{z} p_{y}\left[p_{z}, z\right] \\
& =-i\left(\alpha_{y} p_{z}-\alpha_{z} p_{y}\right) \\
& =-i(\vec{\alpha} \wedge \vec{p})_{x}
\end{aligned}
$$

Therefore

$$
\begin{equation*}
[H, \vec{L}]=-i \vec{\alpha} \wedge \vec{p} \tag{A.1}
\end{equation*}
$$

* Hence the angular momentum does not commute with the Hamiltonian and is not a constant of motion

Introduce a new $4 \times 4$ operator:

- Consequently $S^{2} \psi=S(S+1) \psi=\frac{3}{4}$ and for a particle travelling along the z direction $S_{z} \psi= \pm \frac{1}{2} \psi$
$\star S$ has all the properties of spin in quantum mechanics and therefore the Dirac equation provides a natural account of the intrinsic angular momentum of fermions

- In the part II Relativity and Electrodynamics course it was shown that the motion of a charged particle in an electromagnetic field $A^{\mu}=(\phi, \vec{A})$ can be obtained by makina the minimal substitution

- Since the energy of a magnetic moment in a field $\vec{B}$ is $-\vec{\mu} . \vec{B}$ we can identify the intrinsic magnetic moment of a spin $1 / 2$ particle to be:

In terms of the spin: $\vec{S}=\frac{1}{2} \vec{\sigma}$

- The intrinsic magnetic moment of a spin half Dirac particle is twice that expected from classical physics. This is often expressed in terms of the gyromagnetic ratio is $g=2$.

$\star$ The Dirac current $j^{\mu}=\bar{\psi} \gamma^{\mu} \psi$ plays an important rôle in the description of particle interactions. Here we consider its transformation properties.

- Under a Lorentz transformation we have $\psi^{\prime}=S \psi$ and for the adjoint spinor: $\bar{\psi}^{\prime}=\psi^{\dagger} \gamma^{0}=S \psi^{\dagger} \gamma^{0}=\psi^{\dagger} S^{\dagger} \gamma^{0}$
- First consider the transformation properties of $\overline{\psi^{\prime}} \psi^{\prime}$

\overline{\psi^{\prime}} \psi^{\prime}=\psi^{\dagger} S^{\dagger} \gamma^{0} S \psi
$$

where
