1 At a future $\mathrm{e}^{+} \mathrm{e}^{-}$linear collider, a low mass Higgs boson would be produced via the Higgsstrahlung process shown below.


The respective vertex factors for the $\mathrm{e}^{+} \mathrm{e}^{-} \mathrm{Z}$ and ZZH interactions, are

$$
-i g_{\mathrm{Z}} \gamma^{\mu} \frac{1}{2}\left(v_{e}-a_{e} \gamma^{5}\right) \text { and }-i g_{\mathrm{ZZH}}
$$

and the corresponding matrix element is

$$
M_{f i}=\bar{v}\left(p_{2}\right) g_{\mathrm{Z}} \gamma^{\mu} \frac{1}{2}\left(v_{e}-a_{e} \gamma^{5}\right) u\left(p_{1}\right) \frac{g_{\mu \nu}}{s-m_{\mathrm{Z}}^{2}} g_{\mathrm{ZZH}} \epsilon_{\lambda}^{\nu}\left(p_{3}\right),
$$

where $\epsilon_{\lambda}$ is the polarisation of the final state Z .
a) Taking $m_{\mathrm{Z}}=91 \mathrm{GeV}$ and $m_{\mathrm{H}}=120 \mathrm{GeV}$, find the energy and momentum of the final state Z for a centre-of-mass energy of $\sqrt{s}=250 \mathrm{GeV}$.
b) Show that the $e^{+} e^{-} Z$ vertex factor can be written as

$$
-i g_{\mathrm{Z}} \gamma^{\mu}\left[c_{R} \frac{1}{2}\left(1+\gamma^{5}\right)+c_{L} \frac{1}{2}\left(1-\gamma^{5}\right)\right],
$$

and find an expression for $\left(c_{R}^{2}+c_{L}^{2}\right)$ in terms of $v_{e}^{2}$ and $a_{e}^{2}$.
c) Hence show that there are only two combinations of electron/positron spins which give non-zero matrix elements, and that these are:

$$
\begin{equation*}
M_{R}=g_{\mathrm{Z}} g_{\mathrm{ZZH}} \frac{g_{\mu \nu}}{s-m_{\mathrm{Z}}^{2}} c_{R} j_{R}^{\mu} \epsilon_{\lambda}^{\nu}\left(p_{3}\right), \quad \text { and } \quad M_{L}=g_{\mathrm{Z}} g_{\mathrm{ZZH}} \frac{g_{\mu \nu}}{s-m_{\mathrm{Z}}^{2}} c_{L} j_{L}^{\mu} \epsilon_{\lambda}^{\nu}\left(p_{3}\right) \tag{6}
\end{equation*}
$$

where $j_{R}^{\mu}=\bar{v}_{\downarrow}\left(p_{2}\right) \gamma^{\mu} u_{\uparrow}\left(p_{1}\right)$ and $j_{L}^{\mu}=\bar{v}_{\uparrow}\left(p_{2}\right) \gamma^{\mu} u_{\downarrow}\left(p_{1}\right)$.
d) Taking the $z$-axis be along the direction of the initial state electron, it can be shown that $j_{R}^{\mu}=\sqrt{s}(0,-1,+i, 0)$ and $j_{L}^{\mu}=\sqrt{s}(0,-1,-i, 0)$. Show that the spin-averaged matrix element is

$$
\langle | M^{2}| \rangle=k s\left(c_{L}^{2}+c_{R}^{2}\right)\left(2+\frac{p_{\mathrm{Z}}^{2}}{m_{\mathrm{Z}}^{2}} \sin ^{2} \theta\right)
$$

where $\theta$ and $p_{\mathrm{Z}}$ are the polar angle and magnitude of the momentum of the final state Z, respectively. Give an expression for the factor $k$ in terms $g_{\mathrm{Z}}$ and $g_{\mathrm{ZZH}}$.
e) In the Standard Model, $g_{\mathrm{Z}} \times g_{\mathrm{ZZH}}=8 m_{\mathrm{Z}}^{3} G_{\mathrm{F}} / \sqrt{2}$. Using this relation, show that the total Higgsstrahlung cross section is

$$
\sigma=A \frac{G_{\mathrm{F}}^{2} m_{\mathrm{Z}}^{4}}{s}\left(a_{e}^{2}+v_{e}^{2}\right)\left(1-\frac{m_{\mathrm{Z}}^{2}}{s}\right)^{-2} \beta_{i f}\left(\frac{12 m_{\mathrm{Z}}^{2}}{s}+\beta_{i f}^{2}\right),
$$

where $\beta_{i f}$ is the ratio of the final to initial state momenta in the centre-of-mass frame, $\beta_{i f}=\left|p_{f}^{*}\right| /\left|p_{i}^{*}\right|$, and $A$ is a numerical factor which should be determined.

What is the Higgsstrahlung cross section (in nb) for $m_{\mathrm{H}}=120 \mathrm{GeV}$ and a centre-of-mass collision energy of 250 GeV ?
[ You may require the following information:
i) $\gamma^{5 \dagger}=\gamma^{5} ; \quad \gamma^{0 \dagger}=\gamma^{0} ; \quad \gamma^{5} \gamma^{\mu}=-\gamma^{\mu} \gamma^{5}$
ii) For a massive boson with momentum $\boldsymbol{p}=(p \sin \theta, 0, p \cos \theta)$, a suitable choice of the three possible polarisation vectors is:

$$
\epsilon_{1}^{\nu}=(0,0,1,0), \epsilon_{2}^{\nu}=(0, \cos \theta, 0,-\sin \theta), \epsilon_{L}^{\nu}=\frac{1}{m_{\mathrm{Z}}}\left(p_{\mathrm{Z}}, E_{\mathrm{Z}} \sin \theta, 0, E_{\mathrm{Z}} \cos \theta\right)
$$

iii) In the centre-of-mass frame, the differential cross section for $a+b \rightarrow c+d$ is given by

$$
\frac{\mathrm{d} \sigma}{\mathrm{~d} \Omega}=\frac{1}{64 \pi^{2} s} \frac{p_{f}^{*}}{p_{i}^{*}}\langle | M^{2}| \rangle
$$

where $p_{i}^{*}$ and $p_{f}^{*}$ are the magnitudes of the initial and final state particle momenta. iv) $G_{\mathrm{F}}=1.166 \times 10^{-5} \mathrm{GeV}^{-2} ; v_{e}=-0.04 ; a_{e}=-0.5$.]

2 In an extension to the Standard Model, a new fourth generation heavy charged lepton, $L^{-}$, is proposed with a mass of 1.6 TeV . In addition there would be a new heavy neutrino, $\nu_{L}$ with a mass of 500 GeV . The fourth generation leptons would have the same couplings to the $\mathrm{W}, \mathrm{Z}$ and $\gamma$ as the first three generations.
a) The $L^{-}$would decay via the weak interaction, e.g. $L^{-} \rightarrow \mathrm{e}^{-} \nu_{L} \bar{\nu}_{e}$. Draw the Feynman diagram for this decay and by considering the other possible decays of the W-boson, estimate the branching fraction for $L^{-} \rightarrow \nu_{L}+$ hadrons.
b) Heavy charged leptons could be produced in proton-proton collisions via the Drell-Yan process, i.e. the production of $\left(L^{+} L^{-}\right)$through the annihilation of a quark and anti-quark into a photon. Draw the Feynman diagram for this interaction and explain why the cross section is non-zero for proton-proton collisions.
c) If the squared centre-of-mass energy of the proton-proton collision is $s$, show that the centre-of-mass energy squared of the $q \bar{q}$ system is $\hat{s}=x_{1} x_{2} s$, where $x_{1}$ and $x_{2}$ are the fractional momenta carried by the partons involved in the collision.
d) The QED cross section for $q \bar{q} \rightarrow \ell^{+} \ell^{-}$, where $\ell$ is a charged lepton, is given by

$$
\sigma=\frac{4 \pi}{3} \frac{\alpha^{2}}{s} e_{q}^{2} \times f\left(s, m_{\ell}\right)
$$

where $e_{q}$ is the quark charge (i.e. $e_{u}=+2 / 3$ and $\left.e_{d}=-1 / 3\right)$ and $f\left(s, m_{\ell}\right)$ is a kinematic factor which depends on the lepton mass. Assuming that the $\overline{\mathrm{u}}$ and $\overline{\mathrm{d}}$ parton distribution functions can be described by a single function, $S(x)$, and neglecting the strange quark contribution, show that the parton model prediction for the $\mathrm{pp} \rightarrow L^{+} L^{-} X$ differential cross section can be written

$$
\frac{d^{2} \sigma}{\mathrm{~d} x_{1} \mathrm{~d} x_{2}}=f\left(s x_{1} x_{2}, m_{L}\right) \frac{2 \pi \alpha^{2}}{81 x_{1} x_{2} s}\left\{9 u_{V}\left(x_{1}\right) S\left(x_{2}\right)+9 u_{V}\left(x_{2}\right) S\left(x_{1}\right)+20 S\left(x_{1}\right) S\left(x_{2}\right)\right\}
$$

where $u_{V}(x)$ is the valence up-quark parton distribution function. Clearly state any assumptions you have made.
e) Draw a diagram showing the region of $x_{1}$ versus $x_{2}$ which contributes to the cross section for $\mathrm{pp} \rightarrow L^{+} L^{-} X$ at the LHC operating at $\sqrt{s}=7 \mathrm{TeV}$.
f) Explaining your reasoning, which of the terms, $20 S\left(x_{1}\right) S\left(x_{2}\right)$ or $9 u_{V}\left(x_{1}\right) S\left(x_{2}\right)+9 u_{V}\left(x_{2}\right) S\left(x_{1}\right)$, would you expect to dominate in this region?
g) In the relevant regions of $x$, the parton distribution functions can be taken to have the approximate forms, $u_{V}(x) \approx a x^{-\lambda}$ and $S(x) \approx b x^{-\lambda}$. Taking $f\left(s x_{1} x_{2}, m_{L}\right)=1$, and by performing the appropriate integration over $x_{1}$ and $x_{2}$, obtain an approximate expression for the Drell-Yan cross section for heavy lepton production in terms of $\alpha, a, b, \lambda, M_{L}$ and $s$.

3 In the form of a list with bullet points, write brief notes on three of the following topics:
(a) reactor neutrino experiments and what has been learnt from them.
(b) helicity and chirality in particle physics.
(c) electron-Proton elastic scattering and the measurement of form factors.
(d) electroweak unification and precision tests of the Standard Model at LEP.
(e) $\mathrm{SU}(3)$ flavour symmetry and how it can be used to derive the proton wave-function.
